The Court has already examined the interviews and other public disclosures of the government's case, including the debriefing of the defendant. The Court has concluded that, in the best light for the defendant, there is not an "omission or misstatement of material facts" constituting Brady material as the term has been defined in *United States v. Bagley*, 473 U.S. 667, 105 S.Ct. 3375, 87 L.Ed.2d 481 (1985). Under *United States v. Agurs*, 427 U.S. 97, 96 S.Ct. 2392, 49 L.Ed.2d 342 (1976), the Court concludes that the information and materials requested by the defendant from the government by affidavit, motion, and discovery request, and which was not produced, are not within the type of exculpatory evidence required to be produced under Brady. In Brady, the Supreme Court held that "the suppression by the prosecution of evidence favorable to an accused upon request violates due process where the evidence is material either to guilt or to punishment, irrespective of the good faith or bad faith of the prosecution." *United States v. Agurs*, 427 U.S. at 87, 96 S.Ct. at 2397. The materiality of a Brady violation is to be determined by applying a three part test: "The evidence at issue must be favorable to the accused, either because it is exculpatory, or because it is impeaching; that evidence must have been suppressed by the State, either willfully or inadvertently; and prejudice must have ensued." *Bagley*, 473 c6a93da74d
